### FRIDAY NIGHT BY THE LAKE – SPRING CELEBRATION MAY 10<sup>th</sup> from 6 p.m. – 9 p.m.

A Native and Invasive Plant table will provide information so that we can all learn how to make small changes that can help improve our neighborhood's biodiversity. ### **BRINTON PARK**

**Vandalism**: In mid-April, one of the end posts for the tennis court net at Brinton Park was deliberately destroyed. As a result, the Tennis Court is closed for the foreseeable future. Vandalism in Brinton Park is extremely rare. It is located in the middle of the community, with limited access and surrounded by homes. It is not easily accessible to the general public. We know that the court itself needs to be resurfaced. The cost of resurfacing the courts is estimated between \$4,000 and \$8,000. The cost just to replace the damaged post is approximately \$500. Sadly, the Civic Association does not have the funds to resurface the tennis courts. It does not make sense to replace the post if the courts will not be resurfaced. The Park is still available, and the basketball nets are still there. The paved area can be used for children's wheeled toys. We hope you will continue to enjoy this community asset, even though the tennis courts are no longer usable. We will be discussing future use of Brinton Park, as well as security options, if any. The Community will be

consulted and involved in these discussions. If you have any suggestions or comment, please feel free to reach out to me, John Novak, at john.r.novak@gmail.com or (302) 299-5135.

**Improvement**: The Glen Farms Civic Association, who owns Brinton Park and is responsible for its upkeep and maintenance, is evaluating improvements to the park. These improvements may include remodeling or adding amenities and will be a multi-year project.

For 2024, we have 3 goals:

1. <u>Complete a survey of Brinton Park</u>: A survey of Brinton Park is being performed, including right of ways (ROW) and easements. The survey will be performed by Myers Land Survey Corp. and is expected to be completed this Spring 2024. You may see surveyors measuring the area, as well as setting markers.

2. <u>Establish mowing and lawn care access to Brinton Park</u>: Access to the upper level of the park for mowers and lawn care equipment needs to be added so that workers accessing the park via North Parkway can gain access to the upper level. At present, the lawn care company is accessing the upper level of the park through adjoining property. We are grateful to our neighbors for this accommodation. We expect to be able to access the park directly in 2025.

3. <u>Planning for future of Brinton Park</u>: Lastly, we will begin planning for the future of Brinton Park. Regrettably, it has been ignored over the past years, and we would like to rectify that oversight. We are identifying interested residents who would like to be part of the planning process. ### SUCCESSFUL START AT LAKE GEORGE

On Sunday, April 21<sup>st</sup> neighbors gathered to begin restoring the Lake George ecosystem through invasive plant removal! A huge thanks to everyone who participated in our Earth Day restoration work! It was a fun and successful afternoon! To foster a healthy ecosystem, we must work together to remove the invasive plant species that compromise the success of our native species. Our efforts involved tackling the bamboo, multiflora rose, autumn olive, Japanese honeysuckle and oriental bittersweet that have been taking over. With the helping hands and hard work of many neighbors, we made a lot of progress in just a few hours. It was a wonderful start, but there is still more work to do. Would you be interested in joining future efforts to return the lake to its natural beauty? Stay tuned for an upcoming workday!

Bamboo poles that have been cut and trimmed are available for all of your gardening and DIY needs. They are stacked at the Lake, below the parking lot near the exercise stations.

So, please remember this and do not take items from the common areas (*i.e.*, river stones, reeds, flowers, etc.) without permission. You wouldn't go into your neighbor's yard without permission and pick their flowers. It may seem like one item here or there won't matter, but please try to remember that you may not be the only one doing this, and if everyone takes a flower, there would eventually be no more flowers left to enjoy. Not only that, but it is generally best not to mess with natural resource areas that are managed by others, as we can't know what downstream effects our actions might cause.

### UNWELCOME SALESPEOPLE
